## Guidelines

One (1) book scholarship in the amount of \$500.00 will be awarded to a graduating member of the Class of 2025 or recent college graduate. The recipient of the award will receive \$500.00 each fall semester for three consecutive academic years so long as they are still enrolled in law school at the time of the distribution of the award. The College Senior must attend a College or University located in Madison County, Alabama and must have been accepted to at least one law school, to be eligible to apply. A copy of the law school admission letter must be attached to the application.

- Applicants must have a minimum 2.5 GPA on a 4.0 scale, and plan to attend Law School in the Fall 2025 semester.
- A completed application must include the signed application and supporting documentation (law school admission letter), essay, resume, unofficial school transcript.
- The deadline for submission of the scholarship application is April 30, 2025 at 11:59 pm. No Exceptions.

Secondary source citations must be provided.

Qualified immunity is an affirmative defense that shields state and local government officials from liability in civil rights lawsuits even when they have violated the plaintiffs' rights. When qualified immunity is asserted, the plaintiff has the burden of showing that the right in question was "clearly established" by controlling case law in the relevant jurisdiction.

Roland Edger, a mechanic in Huntsville, was charged with obstructing governmental operations after police were called to a church parking lot where he was fixing a customer's car at night in 2019. Officers arrived and asked Edger for his driver's license. Mr. Edger refused and was arrested for failure to comply. He filed a civil rights lawsuit alleging false arrest in violation of his Fourth Amendment rights against 'unlawful searches and seizures' and a state law false arrest claim after the City of Huntsville dropped the charges. In his civil rights lawsuit, the district court ruled the officers were protected from civil liability due to qualified immunity. Edger appealed and the 10<sup>th</sup> US Judicial Circuit ruled in Edger favor stating that the officers did not meet the requirements for qualified immunity.

Criminal Defense attorneys have long argued that qualified immunity should be abolished because it protects rogue officers from accountability for their bad behavior. This lack of accountability continues to erode the public's trust in law enforcement.

Question: Issues: (1) Whether qualified immunity for government officials should be more narrowly construed in application; and (2) If so, how what changes level of scrutiny should courts apply to protect both the public's civil rights and an law enforcement officer's rights?
